**THE POLYPHONY OF TEXTUAL LOOPS FROM THE SUPERORDINATE
LEVEL OF COMMUNICATION (THE CASE OF SPOKEN LANGUAGE)**

Abstract

A discourse is normally built so as to respect the succession of its component parts towards a certain direction. However, the discourse in question can *deviate* along the way, *return* to its initial direction, *change* its direction once again etc. The *linearity* of the discourse is manifested in a game of *anticipations* and *returns*, resulting in the fact that *continuity* is often threatened by *sequentiality*. All these stand for a true “guiding” of the speech by the locutor. One may also find in the text *comments made by the locutor on his own speech*, but they are not of the same kind as the rest of the discourse. This is also the case of the so called *textual loops*, which we have identified in the *nonrestrictive constructions* taken from the two Corpora of spoken Romanian and from various debate forums on the Internet.

This research sets to underline the pragmatic values of certain *nonrestrictive sentences* - which we call *textual loops* by using a phrase belonging to J. Authier-Revuz - found in the Romanian spoken today, having in view the theory of linguistic polyphony.

MULTIETHNIC CONNECTIONS REFLECTED IN THE ANTHROPOONYMY OF MARAMUREŞ (1987 – 2007)

Abstract

The present study is part of an exploratory research project called MULTIETHNIC CONNECTIONS IN THE ANTHROPOONYMY OF MARAMURES, A CENTRAL EUROPEAN AREA. The grant has been won as a result of a tough competition during 2008 (CNCSIS, nr. 251/2008) and will be in force for 3 years. It aims at investigating the first names used in the North Western part of Romania, a Central European area that used to be a part of the Austro-Hungarian Empire for centuries before the year 1918. It is a multilingual and multicultural area as there are Romanians, Hungarians, Ukrainians, Germans and Romany people that share together the above mentioned area. Moreover, there are people of other ethnic origins that have settled in the region after Romania has joined the European Union. Another important aspect of the research project is the fact that we focus on two completely different historical periods: firstly a totalitarian one, namely the communist regime, and secondly a democratic one that has begun in 1990. The core of the study focuses on the anthroponymic peculiarities of each ethnical group. An interesting fact is that on the one hand they are interrelated, but on the other one the differences tend to be cancelled in the context of the expanding and persisting process of globalization.

Staline a participé, ayant publié trois articles, qui ont formée la brochure *Le marxisme et les problèmes de la linguistique*. À condition du culte de la personne de Staline cette brochure a été proclamée „géniale”, elle a été éditée plusieurs fois en Roumanie. Les idéologues communistes roumains Leonte Răutu et Iosif Chișinevski ont inculpé les trois célèbres linguistes roumains A.Rosetti, Iorgu Iordan, Al.Graur en „marrisme” et en „idéalisme”, le nom de Staline a été évoqué et a été glorifié obligatoirement en la linguistique roumaine jusqu’à 1965.

Résumé

Le but de cet article est d'analyser les désignations roumaines du marié sur la base des atlas linguistiques régionaux. Notre recherche surprend des aspects concernant la distribution, l'étymologie et, surtout, la motivation des termes examinés. Il y a plusieurs facteurs qui ont contribué au rapprochement des deux peuples (serbe et roumain) sur le plan linguistique: la proximité géographique, historique, culturelle et d'autres. Ce rapprochement donne l'explication de la réciprocité dialectale du langage des

deux peuples et celui du Banat. La littérature du Banat se développe dans des conditions spécifiques et pénètre très tard dans la littérature roumaine. D'après certains explorateurs, la langue littéraire du Banat est formée ayant comme point de départ l'œuvre des trois représentants: Ion Popovici Bănățeanu, Victor Vlad Delamarina, Cassian R. Munteanu. Tous en habitant à Lugoj (ou à l'environnement), dans la langue de ces représentants de la littérature du Banat existent des mots d'origine serbe. Les serbismes ont pénétré directement dans le langage du Banat. Les turcismes ainsi que certains germanismes se sont infiltrés par l'intermédiaire de la langue serbe.

En examinant de plus proche les œuvres littéraires de Ion Popovici Bănățeanu et de Victor Vlad - Delamarina, il est évident, qu'il ya des emprunts lexicaux (mentionnés ci-dessus) dans la langue de ces auteurs.

Résumé

Toute l'oeuvre de l'écrivain roumain Gheorghe Craciun (1950-2007) est conçue comme *une guerre entre le corps et la lettre*.

Après l'argumentation théorique docte et tout à fait convaincante sur l'existence d'un côté transitif (voir référentiel, contingent, somatique) de la poésie moderne, un côté complémentaire à la dimension reflexive déjà imposée (**L'iceberg de la poésie moderne**, Paralela 45, 2002), Gheorghe Craciun continue sa recherche du corps de la littérature dans ses romans. Son dernier roman **Pupa russa** propose un expériment littéraire inédit: lui, un homme, percevoir le monde, de l'intérieur du corps d'une femme. Son personnage LeonTina, „une coque à deux noyaux” problématise, en fait, la relation tensionnée entre la corporalité de la littérature (son côté féminin) et le langage (son côté masculin) entre l'auteur, le personnage et le réel. En associant la littérature à „l'anatomie non-compensée” de la femme, le romancier vit des véritables saisons dans l'enfer du corps, mais en dépit de l'aura initiatique de tels expériments somatiques *les illuminations* s'attardent à cause du double rapport à l'expérience corporelle (souvent enthousiasmante) et à son expression verbale (presque toujours une source de désillusion et un appauvrissement du réel).

ÉRIC CHEVILLARD, OR LITERATURE STRUGGLING AGAINST ITS LIMITATIONS

Abstract

What is reasonable to say in literature? Which are the words that matter? These are some of the questions posed in the writing of Éric Chevillard, one of the

most original French writers, for whom the novel is essentially a systematic interrogation of literature and of the world. What drives a writer to write these days? Is it the void, is it the silence of the world surrounding him, or is it a marginality that he could not and would not give up? What does writing mean, after all? Does it mean bringing nuance into a world that can no longer discriminate between differences and grow richer by such discrimination? For Chevillard, writing is both a limit-experience and an experience of the limit; it is a way of trying both his personal limitations as a writer, and the limitations of literature itself. In other words, to write is to go against the grain, to change the established rapport between things and beings, to expand consciousness. The writer is duty bound to experience consciousness to the full in order to be able to name the world in his own way and put it in order as he pleases.

This paper aims to shed light on certain aspects of Chevillard's construction of the novel as a dual enterprise: on the one hand, an undermining of literature, and on the other hand, an immense effort of giving a new poetic meaning to the world.

Quand même, on parle de plus en plus sur l'occidentalisation des élites orientales, parce que la garde des attitudes dominant contemplatives c'est impossible dans un monde de la concurrentiel – et les élites de n'importe quels domaines vivent dans un type ou autre de concurrence. Le livre de Dinicu Golescu, *Note sur mon voyage (Însemnare a călătoriei mele)*, voit plutôt les avantages de la praxis, pas ceux-là de l'ataraxie, frein du progrès pour le bien des tous. Par ce boyard valaque nous avons l'un des plus nombreux esprits qui ne se laissent pas pris dans le confortable piège du passé, mais il pense à la possibilité de construire un meilleur avenir pour son peuple; il ne se contente pas avec des déclamations patriotardes, avec des lamentations sur notre destin malheureux, sur les malheurs de l'histoire par rapports auxquels nous sommes impuissants, mais il veut vraiment changer quelque chose. Ici c'est, sans doute, une perspective illuministe d'un boyard du Pays Roumains par laquelle le boyard valaque part vers l'Ouest pour connaître surtout ses institutions, ayant comme intention à envoyer ses quatre fils pour faire les études supérieures à l'étranger. Roumains cette dualité c'est l'ourdissage sur lequel se tissent les dominants temporaires d'une tendance ou d'une autre.

MIRCEA ELIADE AND THE FASCINATION OF THE PERFORMANCE

Abstract

Although he has never claimed the status of a remarkable playwright, Mircea ELIADE has always been fascinated by the theatrical performance, ever since his youth. In 1939 we wrote the drama *Ifigenia*, a play that has been performed for years at the National Theatre in Bucharest (in 1941 and staged again in 1982). The author's second important play, *Coloana nesfârșită* was written in 1970 and was dedicated, as the title suggests it, to Constantin Brâncuși. Around 1945-46 Mircea Eliade made references in his *Jurnalul* to *Orfeu și Euridice*, a dramatic project that has never been finished. The myth of Orpheus was taken over in his later writing *Nouăsprezece trandafiri*. Another play full of symbols is *Oameni și pietre*, a piece if writing that was published in 1986 in „Revista de istorie și teorie literară”. What we find exciting and challenging is the fact that the vocation Mircea Eliade had for theatre did not take shape in one of the forms of the dramatic genre, but in his short stories and novels. It proves that prose allowed him extensive freedom for the confrontation of ideas, essays gave room to debates, and, all in all, these forms shaped his poetry of the theatre.

NICHITA STĂNESCU. PHILOSOPHICAL INVESTMENT BY THE WORD

Abstract

The work – *Nichita Stănescu. Philosophical investment by the word* - presents the poetic works of Nichita Stănescu, one of the most outstanding poets in modern Romanian literature, concentrating on the poems of philosophical meditation, because that is where the poet's concept of world and life, as well as of the role of poetry in the process of cognition spring from. The first characteristic of this kind of poetry is the link between the judgment ability and sensitivity, between reason and emotion. The second aspect of the analyses poetry is the focusing on the relation between thoughts and words, between words and the language typical only for a poet. The study is divided into five parts which present the poet's gnoseology, the drama of cognition and the pain of existence, time as light and the right to time, natural universe and abstract universe and at the same time the relation between philosophical poetry and philosophy of poetry. The poems and essays are studies side by side in order to discover the key for every foreseen phase of the philosophy of the world. Therefore, the ontological path is bipolar: the poet's gnoseology is reached through transcendence, when the poet, while observing the totality of universe, feels as its tiny part. The poet's verses emphasize the idea of the sphere as a form of universe, as a genetic code which is at the basis of the evolution of the living matter. In his poetry, Nichita Stănescu deciphers the problems of the world through words, through their internal energies. If a notion has no counterpart in a word, the poet resorts to a no/word, creating a short poem out of it. Thus, the understanding of the universe is connected with the relation between notions and words. The poet assesses the hidden tensions, offering an elaborate work created with Love as food to our soul and our mind.

A discuta despre picaresc în literatura secolului XX britanic (chiar și XXI) implică, desigur, cel puțin două direcții de studiu; o încercare de categorizare a acestei literaturi prin care să se demonstreze că există nu numai Modernism și Postmodernism în romanele esențiale ale marilor scriitori, că aceste romane se pot investiga pornind din varii unghiuri de pornire (vezi noua încercare a unui grup de profesori inițiatori ai Victorian Web, sau minunatul efort al doamnei profesor Vianu de a găsi un alt concept catalizator și organizator pentru a putea subsuma și texte oarecum „lăsate pe dinăfară” ale acestei perioade), și că, prin urmare, o abordare genologică nu este doar posibilă ci, poate, deschizătoare de noi orizonturi de așteptare. Cea de-a doua direcție obligatorie este o investigare a elementelor de picaresc, și cum se pot ele „detecta” în aceste texte. Ca studiu aplicat, ne vom referi în special la câteva romane celebre ale „Generației Mâniașe” de după al doilea război mondial în Anglia, pentru a releva că o abordare genologică, și anume prin prisma picarescului re-descoperit în acea perioadă, acoperă și acele romane, sau unele dintre acele romane, pe care critica „mâniașă” sau postmodernă nu le putea încadra foarte ușor.

Abstract

Part of a future ethnological monograph of Romania, *Maramures in the ethnological studies* aims at establishing an integrative synthesis of the folklore and ethnology of this area, framework in which the very preoccupations to collect and value Maramures folklore and ethnology presents an essential interest. Résumé
